School Organizational Team Minutes

The Tarkanian Middle School Organizational Team meeting was called to order at 3:33 PM on May 15, 2018. The meeting was held in the conference room.

- **2.0 Old Business**

- 2.1 APPROVAL OF MINUTES: Presentation, modification, and approval of minutes from the previous SOT meeting.

Minutes: Motion to accept minutes as presented was made, seconded and approved.

- 2.2 GENERAL DISCUSSION: Discussion on any topics team members may have come up with on topics of interest for upcoming meetings.

Discussion: No new topics were discussed.

- **3.0 New Business**

- 3.1 GENERAL FUND BUDGET: Discussion and possible action of the General Fund Budget.

Due to projected shortfalls in the budget by CCSD for the 2018/19 school year, the Tarkanian General Fund Budget was reopened. Tarkanian had a projected \$308,439.60 to cut from the budget. This was determined by the projected student enrollment (2012) multiplied by \$153.30 per student. Dr. Oswald discussed his plan to cut four prep buys (1 - 6th Grade ELA, 1 - 8th Grade Math, 1 - 8th Grade Science, 1 - 8th Grade Social Studies) and cut the materials budget from \$452,329 to \$225,544. Rollover from this year's budget will be used to minimize the impact of the cut from the materials budget. These cuts, along with the budget rollover, will allow class sizes to remain at a ratio of 35 to 1. After discussion, a motion was made, seconded and approved by the SOT to approve the new budget unanimously.
