  - Not sure how valid the information will be
  - Our Data 38% of our families completed the survey
  - Once board makes the decision the parents will be able to make their final decision after the plan is approved
  - We need time to get kids back and schools need time to plan
  - Doing it safely we need time to make sure that's possible
  - Middle school schedule is making it difficult and adds a different component
    - How do we schedule?
    - What does it look like?
  - o If they don't vote how much more waiting because we need to plan
  - Have to call every family to see what they are going to do
  - O What does it look like for students? Teachers?
  - School won't look the same kids won't be allowed to be kids
